NOTICE OF A PUBLIC HEARING REGARDING A SPECIAL LAND USE APPLICATION

Notice is hereby given that the Village Planning Commission of Almont will hold a public hearing on Thursday, May 8, 2014 at 7:30 p.m., or as soon thereafter as the matter may be heard, in the Almont Village Municipal Building located at 817 N. Main Street, Almont, MI 48003.
