### 7.a Fee Clarification

Item #2. Mobile Home Unit Site: When item is used for sewer excavations in a new park, the permit application should include the application fee plus the number of unit sites. When setting a mobile home in a park, or mobile or modular home on private property, a permit should include the application fee, a sewer or building drain, and a water service or water distribution pipe and any other applicable fees.

If the enforcing agency determines a violation exists, it shall be corrected by the responsible installer. The permit application shall include the application fee, the number of water treatment devices recorded in item #24, and the appropriate water distribution pipe system size fee.

Item #25. MEDICAL GAS SYSTEMS shall include the application fee, one Special/Safety Inspection, plus the number of Medical Gas Systems #25. (see Item #20, and the estimated number of additional inspections in #21.)

### 9. Instructions for Completing Application

**General- Plumbing work shall not be started until the application has been approved and a plumbing permit issued. No work shall be concealed until it has been inspected and approved by the Plumbing Inspector. When ready for an inspections call 810-798-8521 noting the type of inspection, the permit number, the date the inspections(s) is requested for and any other important information such as lock box combination or key location.**

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CANCELLED WHEN NO INSPCTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.**

## PLUMBING RESIDENTIAL APPLICATION

Permits are valid for as long as progress is being made and inspections are scheduled and performed within 180 days of date that permit was issued or last approved inspection to confirm that work is progressing on said permit. PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN 6 MONTHS (180 DAYS) OF DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.

Vacuum breakers required on all exterior spigots and any hose bibs or laundry tray that requires/or will use a hose.

Fire stopping required where pipe goes through any top or bottom plate.

One (1) fixture, per branch, on sanitary.

Water pipe must be three-quarter inch (3/4") main, half inch (1/2") to fixture and only one (1) fixture on half inch (1/2") line.

Nail plates required two-inches (2") down from top plate and two-inches (2") above bottom plate.

Stud shoes (or equivalent) required on all non- stud drilled larger than sixty percent (60%) and bearing walls cannot exceed forty percent (40%).

### **THE USE OF TEE'S ON HORIZONTAL LINES IS PROHIBITED, EXCEPT ON DRY VENTS.**

Underground and rough inspections can be covered under one inspection on newly constructed or remodeled homes if ready for inspection at the same time. Additional inspection fee due if not inspected at same time. Additions and remodeling permits require at least 2 inspections, (Rough & Final).

All fixtures must be installed or lines capped for final inspection.

**ABS (black pipe) cannot be glued to PVC (white pipe).** Proper adapter must be used.

**MAY IT BE UNDERSTOOD THAT THIS IS STRICTLY A GUIDE. IT IS RECOMMENDED THAT THE PLUMBING INSPECTOR BE CONTACTED TO ANSWER ANY CODE QUESTIONS. THE PERMIT CLERK IS NOT A CODE OFFICIAL AND IS NOT AUTHORIZED TO ANSWER CODE QUESTIONS.**
