RESOLUTION NO. 15-06-07**

**A RESOLUTION OF THE ALMONT VILLAGE COUNCIL  
UPDATING THE OFFICIAL FEE SCHEDULE OF THE VILLAGE**

The following preamble and resolution were offered by Council Member Lauer and supported by Council Member Peltier.

**WHEREAS**, the Village of Almont intends to collect reasonable general municipal fees that support both general and specific municipal activities, functions, and operations, and

**WHEREAS**, the Village of Almont intends to collect reasonable fees to recover the costs associated with the installation of fiber optic infrastructure in the Almont Research and Industrial Park in 2013 and to recover other costs that may be incurred in relation to such infrastructure, and

**WHEREAS**, the Village of Almont intends to collect reasonable fees to support ordinance and construction code enforcement functions and the administrative duties connected to those functions, and

**WHEREAS**, the Village of Almont intends to collect reasonable fees to support planning, zoning, and economic development activities and the administrative duties connected to those activities, and

**WHEREAS**, the Village of Almont intends to collect utilities fees for purposes outlined within the adopted ordinances of the Village of Almont and to support the operational stability of the Village's water and sewer systems, and

**WHEREAS**, the Village of Almont intends to collect a fee to recover the cost of expenses related to filing for rental rehabilitation grants through MSHDA, and

**WHEREAS**, the Village of Almont intends to establish such fees to recover legitimate costs related to the provision of certain services and the administrative duties connected to those services and not to generate an excessive profit through unreasonable fees,

**NOW, THEREFORE, BE IT RESOLVED** that the Almont Village Council shall adopt the official fee schedule presented to it during the regular meeting of the Almont Village Council held on June 16, 2015 and that the Village Manager and Clerk/Treasurer shall assume responsibility for ensuring the fees included therein are equitably collected.
