

## VILLAGE OF ALMONT

### ORDINANCE 165

**An Ordinance to amend Ordinance 38 adding Section 5; Ordinance 43 adding Section 6; Ordinance 52 adding Section 21; Ordinance 53 adding Section 23; Ordinance 72 adding Section 26 ; Ordinance 75 adding Section 10; Ordinance 88 adding Section 5; Ordinance 93 adding Section 6; Ordinance 96 adding Section 24; Ordinance 107 adding Section 12; Ordinance 109 adding Section 11; Ordinance 119 adding Article III, Section 3.03; Ordinance 123 adding Section 6; Ordinance 138.3 adding Section 2.01; Ordinance 140 adding Section 8; Ordinance 148 adding Section 9; and Ordinance 154 adding Section 5.**

#### **THE VILLAGE OF ALMONT ORDAINS:**

##### Section 1. AMENDMENT TO ORDINANCE 38.

Ordinance 38, Driving; Parking; School Property shall be amended to read in its entirety as follows:

Section 5. ENFORCEMENT. The Police are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Driving; Parking; School Property Ordinance.

##### Section 2. AMENDMENT TO ORDINANCE 43.

Ordinance 43, Solicitors & Peddlers shall be amended to read in its entirety as follows:

Section 6. ENFORCEMENT. The Police and Ordinance Enforcement Officer are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Solicitors & Peddlers Ordinance.

Section 3. AMENDMENT TO ORDINANCE 52.

Ordinance 52, Nuisances shall be amended to read in its entirety as follows:

Section 21. ENFORCEMENT. The Police and Ordinance Enforcement Officer are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violation Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Nuisances Ordinance.

Section 4. AMENDMENT TO ORDINANCE 53.

Ordinance 53, Junk Yards shall be amended to read in its entirety as follows:

Section 23, ENFORCEMENT. The Police and Ordinance Enforcement Officer are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violation Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Junk Yards Ordinance.

Section 5. AMENDMENT TO ORDINANCE 72.

Ordinance 72, Disorderly Conduct shall be amended to read in its entirety as follows:

Section 26. ENFORCEMENT. The Police are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Disorderly Conduct Ordinance.

Section 6. AMENDMENT TO ORDINANCE 75.

Ordinance 75, Curfew shall be amended to read in its entirety as follows:

Section 10. ENFORCEMENT. The Police are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Curfew Ordinance.

Section 7. AMENDMENT TO ORDINANCE 88.

Ordinance 88, Weed & Grass shall be amended to read in its entirety as follows:

Section 5. ENFORCEMENT. The Ordinance Enforcement Officer is hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Weed & Grass Ordinance.

Section 8. AMENDMENT TO ORDINANCE 93.

Ordinance 93, Loitering shall be amended to read in its entirety as follows:

Section 6. ENFORCEMENT. The Police are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Loitering Ordinance.

Section 9. AMENDMENT TO ORDINANCE 96.

Ordinance 96, Water shall be amended to read in its entirety as follows:

Section 24. ENFORCEMENT. The Police and Ordinance Enforcement Officer are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Water Ordinance.

Section 10. AMENDMENT TO ORDINANCE 107.

Ordinance 107, Dogs shall be amended to read in its entirety as follows:

Section 12. ENFORCEMENT. The Police are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Dog Ordinance.

Section 11. AMENDMENT TO ORDINANCE 109.

Ordinance 109, Water Cross Connections shall be amended to read in its entirety as follows:

Section 11. ENFORCEMENT. The Ordinance Enforcement Officer and the D.P.W. Supervisor are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Water Cross Connections Ordinance.

Section 12. AMENDMENT TO ORDINANCE 119.

Ordinance 119, Blight shall be amended to read in its entirety as follows:

Article III, Section 3.03. ENFORCEMENT. The Police and Ordinance Enforcement Officer are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violation of any provision of the Village Blight Ordinance.

Section 13. AMENDMENT TO ORDINANCE 123.

Ordinance 123, Mechanical Code shall be amended to read in its entirety as follows:

Section 6. ENFORCEMENT. The Police, Mechanical Inspector, Ordinance Enforcement Officer, and Manager are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Mechanical Code.

Section 14. AMENDMENT TO ORDINANCE 138.3.

Ordinance 138.3, Building Code shall be amended to read in its entirety as follows:

Section 2.01. ENFORCEMENT. The Police, Building Inspector, Ordinance Enforcement Officer, and Manager are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Building Code.

Section 15. AMENDMENT TO ORDINANCE 140.

Ordinance 140, Garbage Collection shall be amended to read in its entirety as follows:

Section 8. ENFORCEMENT. The Police and Ordinance Enforcement Officer are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Garbage Collection Ordinance.

Section 16. AMENDMENT TO ORDINANCE 148.

Ordinance 148, Burning shall be amended to read in its entirety as follows:

Section 9. ENFORCEMENT. The Police and Fire Chief are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Burning Ordinance.

Section 17. AMENDMENT TO ORDINANCE 154.

Ordinance 154, Hazardous Materials shall be amended to read in its entirety as follows:


Section 5. ENFORCEMENT. The Fire Chief and Ordinance Enforcement Officer are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Hazardous Materials Ordinance.

Section 18. EFFECTIVE DATE.

This Ordinance shall become effective immediately upon publication in a newspaper in general circulation within the Village of Almont.
