

VILLAGE OF ALMONT

ORDINANCE 166

An Ordinance to amend Ordinance 152, Section 2; Ordinance 157, Section 10; and Ordinance 159, Article 20, Section 20.

THE VILLAGE OF ALMONT ORDAINS:

Section 1. AMENDMENT TO ORDINANCE 152.

Ordinance 152 Plumbing & Electrical Code shall be amended to read in its entirety as follows:

Section 2. ENFORCEMENT. The Almont Village Council shall appoint appropriately qualified individuals to serve as inspectors for the Plumbing and Electrical Codes. The Police, Ordinance Enforcement Officer, Plumbing Inspector, Electrical and Village Manager are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Plumbing and Electrical Code.

Section 2. AMENDMENT TO ORDINANCE 157.

Ordinance 157 Address Numbering Ordinance shall be amended to read in its entirety as follows:

Section 10. ENFORCEMENT. The Police, Ordinance Enforcement Officer and Village Manager are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Address Number Ordinance.

Section 3. AMENDMENT TO ORDINANCE 159.


Ordinance 159 Zoning Ordinance shall be amended to read in its entirety as follows:

Article 20, Section 20.00. ENFORCEMENT. The Police, Ordinance Enforcement Officer and Village Manager are hereby designated as the authorized village officials to issue municipal civil infraction citations (directing alleged violators to appear in court) or municipal civil infraction violation notices (directing alleged violators to appear at the Village of Almont Municipal Ordinance Violations Bureau) as provided by Ordinance No. 163 for violations of any provision of the Village Zoning Ordinance.

Section 4. EFFECTIVE DATE.

This Ordinance shall become effective immediately upon publication in a newspaper in general circulation within the Village of Almont.
