TERMS AND CONDITIONS:

1. Permit holder must comply with Village of Almont Ordinance 195 and any other applicable ordinances.
2. All work performed under this permit must be done in accordance with application and statements filed with the Village of Almont.
3. Any street, curb or sidewalk that is damaged or removed due to construction must be at the correct grade and repaired upon completion by contractor.
4. Any utility (storm, water or sanitary) that is below grade or damaged must be at the correct grade and repaired upon completion by the contractor.
5. The permit holder shall be responsible for all costs incurred by the Village of Almont in connection with this permit.
6. The permit holder is required to provide a surety bond in the amount of \$ 2,000.00
7. The Village of Almont reserves the right to make inspections at the time to verify proper construction and compliance with Village of Almont standards, policies, and ordinances.
8. Issuance of this permit does not relieve the permit holder from meeting any and all requirements of law or of other public bodies or agencies. The permit holder shall be responsible for securing any other permits necessary or required by law for the activities hereby permitted.
9. The work covered in this permit shall be completed within 6 months of the issuance of this permit. If the work is not completed by this time and an extension has not been granted prior to permit expiring, the permit will be void and permit holder must reapply.
10. Any violation of these terms and conditions will result in an invalid permit.


