


# **Project Overview**



# Aerotropolis designation could mean more than 36,000 jobs for Interstate 69 corridor

FLINT TOWNSHIP, Michigan -- Genesee County Commissioner Jamie Curtis called an impending aerotropolis designation for the Flint area and partners in Shiawassee, Lapeer and St. Clair counties a momentous occasion.

"It's history in the making. This is a one-time opportunity," said Curtis of the designation that would allow for tax incentives for 33 communities -- including 10 in Genesee County -- along the Interstate 69 corridor. "This is the tool for the toolbox to bring jobs to the area."

The partnership has been in the works for nearly one year. The idea was made possible through state legislation passed 2010 in December.

"I look at what we have today, and I am very proud," said Jim Rice, director of Bishop International Airport, during the Next Michigan Development Corp.'s first meeting Thursday. "What it means is you all, right here, are working to make our future brighter."

An application is being sent to the Michigan Strategic Fund to make the I-69 corridor an aerotropolis. Approval of the application, possibly during the Feb. 22 Michigan Economic Development Corp. meeting, is the final step.

Gov. Rick Snyder has already signed off on the corporation's approval, soon to be one of five in the state and third behind groups in the Lansing area and Wayne County. Traverse City has also shown interest in the aerotropolis designation.

The move would allow the group's partners to offer tax incentives to businesses hoping to do work or move into the area. The intent is to attract work in multi-modal

transportation opportunities, including airports, rail lines and highways.

Janice Karcher, vice president of economic development for the Genesee Regional Chamber of Commerce, said a market study performed during the process found 21,000 jobs could be created over a 20-year period with another 15,000 possible through residual business.

"This allows us to promote ourselves and it registers with different parts of the world," she said.

Flint Mayor Dayne Walling said with the city's location between Toronto and Chicago, "We offer a great location for new companies in any type of shipping and transportation."

Rice said the airport could expand with jobs in shipping by manufacturing companies or the cargo sector, while also handling public and private air travel.

Dan Casey, chief executive officer of the
Economic Development Alliance of St.

Clair County, called the move important to
regain control of perspective for communities.

"We have shipping on the Great Lakes, the ports are still there, but they're not being utilized like they should be," he said. "(This move) will create a new tax base, create new jobs, create new energy."

Curtis emphasized the need to work with other communities, so none are left behind in a changing business environment.

"If we don't collaborate and come together as a region, you won't have the opportunity to bring those businesses here," he said. "There's no borders anymore" in business.

## Officials set up intercounty trade group

FLINT TWP. — Representatives from nearly 33 municipalities Thursday formally agreed to create the I-69 International Trade Corridor Next Michigan Development Corporation during a meeting at Bishop International Airport.

Gov. Rick Snyder's recent approval of the interlocal agreement moves the partners one step closer to the culmination of a year-long effort to form the consortium, which will focus on promoting the area as a transportation hub.
